Thaddeus Beal is a consummate Boston artist. Boston born-and-bred, as well as a graduate of the Museum School, Beal has been a Mass Council Fellowship finalist five times, and won three times. Beal is also a New England Foundation for the Arts Recipient.

Beal's work has been shown in galleries in Boston and New York, and collected by Boston's Museum of Fine Arts, among other institutions. He is represented by Soprafina Gallery.

He has received grants from the National Endowment for the Arts and The Graham Foundation. His work earned Institute Honors from the American Institute of Architects in 1992.

His photographs are in the collections of the Museum of Fine Arts, Boston and the Addison Gallery of American Art. In 2009 the Boston Athenaeum presented Vanderwarker's Pantheon: Minds and Matter. He is represented by Gallery NAGA Boston.

Guidelines:

Competition is open to all artists 18 year and older.

Each artist may submit jpgs of recent original 2D or 3D artworks (artwork must be framed, ready to hang or otherwise display) in any medium. The image submitted must accurately represent the art being submitted.

Artist is responsible for any display needs such as pedestals, etc.

If work is accepted, artists are responsible for shipping costs to and from the gallery.

NB: The gallery is not responsible for any works damaged in transit to/from the gallery or from any damage resulting from poor framing.

A non-refundable fee of \$35 entitles the artist to submit up to 5 pieces of artwork for consideration. Only one image per artwork, please.

The gallery may decide to accept any number from zero to all 5 pieces for the show.

You may submit work as NFS, but need to submit a price for insurance purposes.

For all sales, Artist-Gallery split is 50%-50%

Digital image guidelines:

Must be jpeg files, approx 300 dpi and 4 x 6 inches. They should be named in the following manner:

[Last name]_[First Initial]_[Title]_[dimensions].jpg
